

1. Article X, Use Restrictions, of the Declaration, shall be amended to add an entirely new Section 10.6, Surveillance Cameras, to read as follows:

10.6 Surveillance Cameras. Unit Owners are permitted to install surveillance cameras (such as Ring or similar video doorbell cameras) on the outside of the Unit Owner's entranceway door or on the exterior of the building service adjacent to the Unit's entranceway door, with the prior written approval of the Association, and the surveillance camera shall not be considered a material alteration or substantial addition to the common elements requiring a vote of the unit owners. Any unit which currently has a surveillance camera on the Unit's entranceway door or on Condominium Property as of the date of the recording of this amendment shall be grandfathered. As of the date of this amendment, all newly installed surveillance cameras must be installed in accordance with this provision. The approval of the Association will be conditioned upon privacy considerations of neighboring properties. The Board of Directors reserves the right to demand the removal of any camera if it is determined, in the sole discretion of the Board, that the camera's use or positioning violates the privacy of other Unit Owners. The Board of Directors may promulgate further rules and regulations relating to the installation and use of surveillance cameras by Unit Owner(s) from time to time. The Association shall have no liability for a Unit Owner's use of a surveillance camera.
